

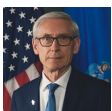
Appointments Made to Governor's Task Force on Student Debt

MADISON — Gov. Tony Evers announced on Monday appointments to serve on the Governor's Task Force on Student Debt. The task force was created through [Executive Order #67](#) and is tasked with addressing the growing student debt crisis in the state of Wisconsin. [Department of Financial Institutions \(DFI\)](#) Secretary Kathy Blumenfeld will serve as the chair of the task force.
