Background: In 2016, billionaires with Wisconsin-based businesses – Richard Uihlein and Diane Hendricks – spent \$20 million to get Johnson reelected, and their investment paid off big time. In 2018, they received a combined \$80 million in tax breaks from just one little tax cut Johnson carved out for wealthy business owners in the Trump-GOP tax cut legislation passed the year before. That tax cut personally benefited Johnson, helping him to DOUBLE his wealth since he became a U.S. senator, selling his business for up to \$25 million in 2020. Now Uihlein and Hendricks are spending heavily to elect Senator Johnson to another 6 year term.
