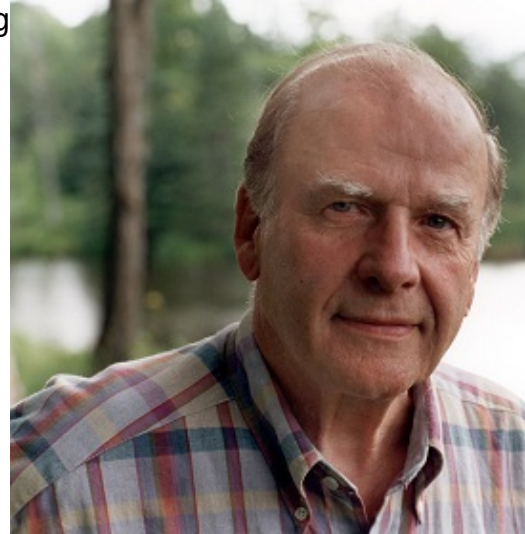


Wisconsin Conservation Voters announces endorsements for April 2022 Election
